TERMS AND CONDITIONS

SPACE LOCATION: Space location is restricted to the Library Plaza. **Because vehicles are not permitted on the plaza, please be prepared to personally transport your merchandise from the parking lot. In warm weather please consider bringing sun cover for yourself.**

REGISTRATION: Vendors are required to register at the ASI Office located at CSU San Marcos in FCB5103 prior to set up their first day. After registration, vendors will receive a permit to display. Vendors who fail to provide proof of registration and payment via permit may result in immediate removal from campus, refusal of future COUGAR BAZAAR participation and/or any other actions decided by ASI.

REFUNDS: ASI will refund a vendor **ONLY** in the case of rain in the form of credit toward another date. **NO PAYMENT REFUNDS** will be offered.

PARKING: There are two options: First, free sponsored parking passes are available for all vendors who pay by the payment deadline. For late comers, vendors may purchase a daily parking permit in any of the general lots for \$7.00 per day. University police may issue a citation if daily permits are not displayed clearly on the dash board and visible from the outside. Permit machines are located in general lots B, C, N, and O.

- By signing below the vendor affirms that the above registration information on pages 1 and 2 is true and correct and that the vendor has read, understands, and agrees to abide by the above stated provisions.
- The vendor shall not make any representations which may indicate an endorsement or guarantee by CSUSM or Associated Students, Inc.
- The vendor may not imply that the vendor is an agent or representative of CSUSM or Associated Students Inc.
